Wine Club Agreement

- Colorado liquor laws will always supersede Wine Club rules and must be followed at all times.
- Membership includes a temperature controlled wine locker that holds up to 12 bottles that can be purchased through the club and stored for consumption on the premises at member's discretion.
- Wine Club Members will receive a 30% discount off of retail wine bottle purchases. Both
 wine club and non-wine club pricing will be on the wine list. Discounts are for bottles
 only and will not apply toward "By the Glass" purchases.
- Wine Club Members will be given advanced reservation opportunities for all wine related events and will receive a 20% discount off the price of the event.
- At times throughout the year, our special relationships with our wine purveyors allow us
 to purchase unique, specialty or hard to find wines. Wine Club members will be given
 the opportunity to participate in our "Flash Sales" where incredible savings will be
 passed on to our members.
- Wine Club Members will have access to purchase selected wines through the Club that will be exclusive to the Wine Club. Management will determine the list and it will vary monthly.
- Wine Club discount specifically applies towards A La Carte dining and may not be used for Member Events, Private Events or Tournaments.
- The Wine Club discount is only available on bottle purchases and will not be applied to wines by the glass.
- The minimum term for membership is one year. Membership will roll-over into the next year unless the Club is given a 30 day cancellation notice to terminate membership. Any wine not consumed on property by the end of the 30 day notice will become property of the Club. Payment schedule is \$40 billed on the 25th of each month for next month's wine club or we will accept an annual payment of \$480.00. If the annual payment option is used, the club will provide one complimentary bottle (Club's choice) which will be added to your locker.
- The Club will schedule a minimum of one wine event per every two months pending schedule availability.
- The Wine Club is limited to wine only. No beer or liquor may be stored or purchased with discount.

- Unopened bottles are never allowed to leave the property. Colorado "Cork & Go" laws allow less than .750ml of wine to be taken off property provided the cork has been driven deeply back into the bottle ("Stelvin" or Screw Cap enclosures cannot leave the property), the wine is placed inside a sealed bag, and the bag is placed in the trunk or other area of the car not occupied by passengers. Only one bottle may leave the club per Wine Club member per day.
- To stock your locker all orders must go through a Food & Beverage Manager. Servers
 or Bartenders cannot take wine orders for lockers.
- White wines will not be stored chilled. It is the member's responsibility to inform the Club
 ahead of time if a white wine needs to be chilled ahead of time.
- The Club will only store 750ml bottles
- Monthly wine club payments must be billed to membership accounts.
- The Wine Club is a "Club within a Club" and management reserves the right to eliminate the program at our discretion. If this occurs wine previously purchased by members will be stored for up to 6 months for consumption on property.
- For billing purposes, Wine Club space cannot be shared by multiple members
- All Wine Club purchases are final.
